Dear WMS/CNS Coordinator:

The purpose of this letter is to introduce the 3/06 Intranet version of the 'LDSS-4398: 'WMS Non-Services Code Cards'. This update is a result of WMS/CNS enhancements that were migrated to the Production System on March 27, 2006.

Since the Intranet computer software automatically renumbers pages as well as updating revision dates on all pages, it is not possible to highlight updated pages with a distinct page number and revision date. Attachment I, however, details the changes that have been made to the code cards. The pages listed in the attachment can be individually printed and inserted into the 11/05 version of the card stock. By utilizing this option, workers need no longer make pen-and-ink changes to the card stock.

Basic instructions for reading and printing the Code Cards are provided on the Intranet WMS Code Card Access Screen.
