

CNS reason codes G44 and G45 are being replaced with W44 (Probation Violation) and W45 (Parole Violation). Policy requested language changes to allow the capturing of additional information; these codes will now be extensive fill requiring worker input for the issuing State, issuing Agency, and contact telephone number. The reason codes will function off the WCNW30 screen, which has been modified to handle these new codes as well as W35 (Fleeing Felon).
