Z61-Z62/8306- Housing Expense

Question has been added asking if free housing is received as part of pay.

Z61-Z62/8310- Parent or Spouse outside the home

Blurb has been added under the question of spouse’s information which reads, “Note: All families who are renewing for their children and pregnant women are NOT required to fill out this section. All other people who are applying and are age 21 or over must be willing to provide information about a parent of an applying minor, or a spouse living outside the home to be eligible for health insurance, unless there is a good cause.”

E0007 – Explanation of the Excess Income Program for Non-Immigrant/Undocumented Immigrant Alien Emergency Only

Bullet has been added under the title “Payment of Medical Bills” which says “Medical Bills for your parent(s) may also be used toward meeting your monthly excess if you are under 21 and live with your parent(s).”

E0030- Explanation of the MBI-WPD Program

Sentence added, “If married, your resource limit is always for a household of 2.”

E0032- Explanation of Citizenship/Identity Documentation

Medical Assistance has changed to Medicaid.

Section 3- Long Term Care Restrictions Revised and Medical Assistance changed to Medicaid

New Blurb has also been added which states, “If you start receiving nursing facility service on a permanent basis, notify your social services district immediately. We will then arrange to review documentation of your resources for the transfer of assets look-back period (up to 60 months) to find out if you are eligible for Medicaid coverage for these services. We will also determine if you will have a contribution to the cost of your nursing home care.”

Section 6- Change to Processing of Automated Renewals

Renewals generated through the automated renewal process will be pulled the second weekend of every month beginning in July 2010.

Section 7- Case Level reason codes with Budget Types 05 and 06 (single person cases)

Changes that were made with the 2010.1 migration to financial Discontinuance and Undercare codes did not allow workers to use reason codes at the case level with Budget Types 05 and 06 when there was only one person on the case. The programming has been changed for this migration to allow Case Level reason codes with single person cases. Please note that with a case count > than 1 individual level reason codes are still required.
