**Section I: New Informational Notice for Over 65 Years who Need to Enroll in Medicare**

A new informational notice has been created for the automated process or for manual CNS entry. When manual CNS entry is needed, the informational notice will be generated from the WMS/Client Notice Subsystem Menu by selection 07 - Notice Authorization/Release. This informational notice can be used on Medicaid (CT 20) or Temporary Assistance (CT 11, 12, 16, 17) cases. A record of this notice can only be seen through the Notice History from CNS Menu as a WMS transaction does not occur with it.
