Your NYS Benefit Identification Card:

If you are a new Medicaid/Family Planning Benefit Program recipient, a New York State Benefit Identification card has been mailed to you. If you received benefits in the past and were sent a card, a new card may not automatically be mailed to you. You must bring your New York State Benefit Identification card with you each time you use medical services. Please keep your card in a safe place and let us know immediately if your card does not work, is lost or stolen. Keep this card even if you stop receiving benefits. The same card may be used again if you become eligible in the future.

If you are or become enrolled in a Managed Care Health Plan, you will use your health plan card for plan covered services, including pharmacy benefits. You must bring your plan card with you each time you need covered medical services. If you are enrolled in a health plan that does not cover certain services such as Family Planning or Dental care, you must use your New York State Benefit Identification card to obtain those services. Please refer to your health plan handbook for what services are covered by your plan.

Su Tarjeta de Identificacion de Beneficios del Estado de Nueva York:

Si usted es un nuevo beneficiario de Medicaid/Programa de Beneficios de Planificacion Familiar, se le ha enviado por correo una Tarjeta de Identificacion de Beneficios del Estado de Nueva York. Si anteriormente usted recibio beneficios y se le envio una tarjeta, probablemente no se le envie por correo automaticamente una nueva tarjeta. Usted debe traer consigo la tarjeta de Identificacion de Beneficios del Estado de Nueva York cada vez que use los servicios medicos. Guarde su tarjeta en un lugar seguro y dejenos saber inmediatamente si su tarjeta no funciona, la pierde o se la roban. Guarde esta tarjeta, aun cuando cese de recibir beneficios. Usara la misma tarjeta nuevamente si en un futuro reune los requisitos para recibir beneficios.

Si usted esta inscrito en un plan de cuidados administrados de salud, usara la tarjeta del plan de salud para recibir servicios comprendidos dentro del plan, inclusive servicios de farmacia. Usted debe traer consigo la tarjeta del plan cada vez que solicite servicios medicos comprendidos dentro del plan. Si usted esta inscrito en una plan de salud que no cubre ciertos servicios tales como Planificacion Familiar o Cuidados Dentales, usted debe usar su tarjeta de Identificacion de Beneficios del Estado de Nueva York para obtener

servicios. Consulte el manual del plan de salud para saber que tipo de servicios estan incluidos.
